If you are eligible for OSAP and **have not** previously applied for OSAP for 2017-2018, you must complete a 2017-2018 online OSAP application, in addition to this “Undergraduate Supplemental Application”. - 2) Students enrolling in one distance studies half course, one distance studies full course, or one evening half course ONLY must complete the “OSAP Application for Part-Time Students” web application, which can be found online at <https://ontario.ca/page/osap-ontario-student-assistance-program>. Once your application is submitted, please hand in your completed signature pages and required documentation (if any) to Western Student Services Building: Student Financial Aid, Room 1100. **Part-Time Application and Supporting Documentation Deadline is 42 days prior to your study period end date.** Students enrolling in one distance studies full course and have a permanent disability have the option to apply for Full-Time or Part-Time OSAP.
- 3) Please notify Student Financial Aid, immediately *in writing*, of any changes to your application.
